The Board and their attorney met in regular session today.

Mrs. Paul Hayward and Mrs. George Spence representing the County Council Women Homemakers clubs asked that in the Budget for 55-56 Miss Joy, Home Demonstration agent be allowed an assistant to work specially with the teen age group. To be considered.

Dr. Houser requested that part of his expense allowance be paid to Dr. Locke, inasmuch as Dr. Locke will have so much extra work to do. For consideration.

Paul'Bell's bus from Lex. Pk. overcrowded, this is the 2nd bus and most of the riders prefer this one as the first bus leaves there too early. Letter written to Mr. Geo. Dederer asking that high school students take the first bus from the park and the first bus returning from school. Complaints that Leonard Hall boys were also riding this bus were referred to Mr. Bell- 5 boys- and he will notify his driver to discontinue carrying the boys.

Mrs. Weigman of Piney Point called about the drainage on her land. Bd. agreed to meet her at her home Tues Nov 16, and view conditions. They will report their findings and make suggestions for remedying the problem.

Mr. Richley Delehay and wife signed an Agreement allowing the RC to go on their property for the purpose of constructing a road-as soon as DEED can be prepared giving Right of Way Delehay's will execute that. Mr. Thompson has been advised that agreement has been signed, and requested to get to work on this road at once.

Dr. Locke with Mr. Wiley E. Hartwell called with reference to the latter's appointment as Plumbing and Bldg inspector. The appointment becomes effective November 15, at a salary of \$2400 annually, payable monthly with wht and so.sec. taken out. Other applicants were Ed O'Brien, Mr. Link, Lex. Pk and Mr. Barber Charlotte Hall. Mr. Hartwell was previously employed with the Washington Suburban Sanitary Commission and is considered qualified for the job. The Health Dept will prepare a Code for this work which when and if approved by the County Commissioners will then be sent to the members of the Md. State Leguslature with recemmendations that it be enacted into law.

Geo. Clarke of the Leonardtown Dairy asked that preference be given his dairy products by the public schools of the County. Letter was addressed to Mr. J. Claude Johnson to this effect.

One of the laws which the Bd hopes to have enacted is that which will specify the size type to be used in legal ads which have to be published, i.e., Election and other Notices, annual audit etc. 8 pt type on 9 pt base condensed is good size.

Robt. Miedsinski, who takes oath of office as Sheriff on Dec 6-1954 asked that his deputies be increased in salary to \$3600 each, with cars provided by the County, as well as uniforms, and permission to approint as many more over the 3 the law allows, as he may need.

Permission was given him to order the uniforms but the matter of cars and salary will have to become a law before it can be done. His own salary cannot be increased during his term of office

Bpard suggests that the following matters be discussed with the members of the Md Legislature that bills may be prepared for same and action taken in the coming 1955 session;-Number of deputies sheriff may appoint, car for each deputy owned by the County + salary of each deputy to be increased to \$3600 annually Specify size type for all legal ads Set amount of rent for all voting places Plumbing Code and duties of Plumbing Inspector Set Master Plummers annual fee \$25.00 Journeymen, \$10.00 for Registration

Mr. Frederick Tilp, architect talked about enlarging Court House Sent in graph showing location of various agencies in Charles County Court House- we have the new office bldg for many County agencies but the Clerk to the Circuit Court and other offices are crowded. Matter will receive thought.
