The Commissioners and their attorney met today in general session.

Check has been received for \$81,499.25 from State Comptroller for share in SRC bonds. Treasurer has same.

Walter Norris, Hollywood, Md. to sell dog tags in 6th Dist Clinton Duke Leonardtown, Md " 3rd -4th .

It was explained to both that they receive \$1.00 for every tag sold, but money and duplicate receipts must be brought to Treasurer who will then pay them

Tax Review set for Dec 15, may need 16th also. This is a General County Tax review

State School Loan, \$221,000- Miss Dent called to have the Commissioners sign a request for additional State School Loan which was done- also desired to know how much had been drawn to the Hollywood School so far- and was informed it amounted to \$37,747.91. Further desired to know when and how much she would receive from the Wherry Project-Center Gardens* taxes, the share due the Pub Schools of St.Mary's. Mr. Lipski was present and advised her the Treas deposits all taxes in one fund and from that she receives 65/150 over a period of 10 months, this money is included in the allotment made in the budget. After July 1, 1955 she will receive 75/150 of this money.

Enrolled in St. "ary's County Pub. schools as of Sept 30-1955 there were 3,124 white pupils and 1,32 colored pupils.

Miss Dent informed the County that she has the deed for the Frank K_{nox} School the some additional work is necessary before it can be recorded.

Auditors came to explain the chart and graph they sent in with the audit for 54-55 Chart shows percentage received from each source, and how it is spent-very instructive and interesting-they suggest either having cuts made so the charts may be published in the County papers, or having small pamphlets printed to send out with Tax bills and have in County postoffices so public may take them and read what happens to the tax and revenues collected by the County.

Auditors request they be paid the 3rd quarter for 55-6 at the rate set in the last budget \$1,075.00 and then for the last \(\text{Apirl-"ay-June} \)) they be paid at the rate of \$6,000 per yr-or \$1500.00. Mr. Gruber explained that the work had increased to a great extent and the auditors received many calls for assistance by the various County agencies, and they felt that this warranted additional compensationn-should the work decrease, they will make refund or ask for less. Clerk was instructed to allow \$6,000 in the 56-7 budget.

Commissioners went over the budget which had been prepared and is now ready for public inspection. Pearing set for Dec 13- at 2 pm
