Miss Dent presented request for \$90,000 for teachers increment for 56-7 read scale of salaries for Md schools and St Mary's County is lowest. is almost impossible to secure teachers when other counties bid for their services at higher salaries. Mr. Guy suggested that within the past 5 years St Mary's County teachers had been raised \$700 -feels the Gen Assembly should pass law setting salaries for teachers in each grade. Miss Dent pointed out that many janitors receive more than some teachers.
