All members and their attorney present at today's meeting.

Olin <sup>M</sup>attingly verbally agreed to be responsible for the \$1,000 necessary to dredge ~~channel~~ at St. Patrick's Creek. Mrs. E. Jackson sent a check for \$100 as her part in this.

In the afternoon Mr. Freeborn <sup>B</sup>rown of BelAir, Md demonstrated the Shoup Voting Machine; besides the Commissioners the Election Board and members of various agencies were here.

Mr. Brown explained that the machines can be paid for cash-in two or ten years with a clause in the agreement of sale whereby the yearly payments may be accepted towards the purchase price. He also stated there would be someone to demonstrate the use of the machines- without cost- at the time of election; machines would be delivered without cost- machines are guaranteed for 5 years. He was asked to submit bids on

29 or 34 machines, with part payment plans

Letter was sent to Automatic Voting Machine Corp-Jamestown, NY for the same information and bids as above.

At request of Commissioners-Court House Bldg Committee was present when Mr. Tilp with Mr. Wilson, engineer, came in about the Court House plans and talked about the condition of the existing roof. It was determined that he should go ahead with proper and necessary repairs etc., to the roof to make it perfectly safe as it is in a dangerous condition at present.

Estimated cost of necessary repairs to roof about \$35,000.00. Mr. Tilp said plans would be ready for bids the end of January.

Board adjourned at 5 pm.
