

April 24, 1956

Commissioners and their attorney met in regular session today.

Letter to Mr. Evertt Milburn, St. Mary's City, advising his dogs killed 2 pigs belonging to Mr. Balto. Mr. Milburn will either have to pay for the pigs or get rid of the dogs.

Mrs. W.W. Hutchins of Tall Timbers came in about a section of old road-matter for the State Roads Commission before the County enters into it.

Dr. Houser and Dr. Locke came in about the Trailer Camp fees etc. They feel the County could collect \$3,000 from this source. If the Board would adopt a Sewer Ordinance and change the Sanitary Code, making it similar to the other Counties in Md, they would bring them in about \$35,000.00 per yr; Septic Tank permits would yield \$3,000. This is the only County where restaurants, bars etc., are inspected without charge. Where food and drink is consumed they could charge \$10 per yr and for "off sale" places a fee of \$5.00 per yr. If these charges were made they would more than pay the expenses in the budget for the Health Department-salaries etc.

Mr. Clemens Gaines and Dr. Houser came in that afternoon to talk about a larger Health program for the County, where the State matches \$1 for \$1. Mr. Gaines will mail a detailed program to the Commissioners, and they will decide about it later. The program covers State or County owned cars.

Bay Forest Road-letter to Wm.C.Rogers,Rogers Bldg,Balto Md., advising that the Commissioners require \$6,500 to improve,gravel and surface treat the County road leading into Bay Forest Estates. Road will be improved and gravelled within 6 mos after notification that the above sum is being held in escrow by their company, and after completion of the above work the payment of \$5,000.00 will be necessary. After the road is thoroughly impacted, as soon as possible thereafter the surface treatment will be made and the sum of \$1,500 must then be remitted.

State Roads Commission advised the County has accepted the Easley Road-in St. Jerome's Manor Corp recorded in liber CBG 62 folio 321.
