Mr. Tilp and Commissioners inspected the Welfare Bldg and Mr. Tilp was requested to present preliminary plans for remodelling and addition of 2 rooms 16 ft, long by present width, one on 1st floor one on second floor.

Messrs. Tennison, Jordon and others, complained about the low spot in the Blackistone Rd in front of the former's store, which caused water to drain on to Jordan's land under his house. After discussing the road with Jr. Raley he advised he would put gravel on low spot and pack it down. They were advised road will be surface treated during August 1961.

Mrs. Pio, Mrs. Berry and Mrs. Egnlish, regarding County Mental Hygiene advised there were 3 rooms at St. Mary's Hospital which Mr. Christman had agreed to make available for this purpose. There patients can be checked to determine whether or not they need mental treatments at State hospitals. Rooms will require special equipment for this use. Commissioners will support this program, but program should be prepared with the hospital and presented to the Commissioners.

Cuniberti Farms and Aviation Yacht and Country Club sub-divisions:Dr. Houser was asked to come in regarding the above planned subdivisions.
Dr. Houser informed the Commissioners that regarding these projects, the
Health Dept could not say how many restrictions would be placed on them,
due to damage to oyster beds, until the water has been contaminated. Commissioners would like an opinion from Mr. Robt. Frown, Chief, Bur. Environment
& Hygiene, State Health Dept. Letter was written Mr. Frown requesting this.

Dr. Houser discussed with the Commissioners the possibility of securing the Gerwig Clinic building, beside the Hollywood School, is desirable for the Health Dept. which is short of space. He was advised Commissioners have in mind as part of the program for use of the Surplus Property buildings at Lexington Park a Health clinic, but nothing can be done until the Commissioners hear from GSA, before deciding on the Gerwig Clinic.

Ben Hill, parochial school contractor, advise he cannot operate his paro. sch. bus to Cardinal Gibbons Institute from Chaptico area at the present amount he receives, and asked that route be rehid. Notice was placed in St.Mary's Beacon to run 2 weeks, bids to be opened Aug 8, 10; apm. Bus Contractors to meet 2:30 8/1, for extensions, and renewal of contracts.

Mr. Myer of IBM was here to talk about dictaphone Mr. ohnson wants. No decision was reached at this time; no future date set for further discussion.

SRC:- Jr. Raley (now in charge of County road system) came in for a general discussion of progress on roads ; and list of roads to be be worked on next. Elias Gant, Dameron, concerned with entrance to his property, was advised to contact State Roads Com. for permit to install pipe- not a County matter.
