After a lengthy discussion, Commissioners requested Barnard Smith to come in at 2 p.m. Mr. Bodine returned for this meeting. Mr. Smith informed the Board that nothing can be done to lessen noise made by the fan, due to its enormous size and the valume of air it withdraws and to cover the fan in any way would defeat its he felt it would cost no more to cut the fan off at 9 p.m. and to start it at 8 a.m. daily. There is some feeling among the employees of the Court House, and the attorneys who also work here, that to cut the fan off at night during extremely hot weather and then start it at 8 a.m. the building would not be comfortable for working in the early hours, and fan should be kept running. Mr. Smith agreed to make a survey of the temperature of the building for a week, with fan stopped at 9 pm and started at 8 a.m. and he will advise the Commissioners of the results.

Carroll Morgan, of Smith's Inc., was requested to air-conditioning the 2nd floor of the County Office Bldg. He made a survey as to how many window units would be required, since he felt it would cost less to use them than any other system, but was not sure the present electric system would carry the extra heavy duty thus required. Commissioners asked Mr. hing to come in and informed him they felt the regular air conditioning system would be cheaper to operate than the window units, but nothing can be done this year. They will contact him later and plan something for 1962.

Atty. Jos. Weiner with Jos. Dobry and a group residing on Horse Head Rd came to ask when that road would be black topped. IIt was gravelled in April 1960 and nothing done since then, tho repeated requests have been made as to when it would be completed. After a telephone conversation between Commissioner Hodges and Mr. Thompson, SRC, they were assured the road would be ready for use by the school busses in Sept. SRC is working on the road getting it ready for blacktopping. Letter was sent to Mr. Thompson, SRC, requesting that he complete the necessary data work in order that the road may be surface treated.
