All officials present in the morning, Commissioner Hodges absent in afternoon.

1. SRC Bailey, M.C. Thompson, Jr, Dist. Engr and Jr. Raley County Res. Engr met to discuss and approve entrance to property of Chas. Wood, St. Ary's City. Mr. Thompson advised that the SRC will purchase R/W from John Lancaster for \$2,500.00, price Lancaster requested, County will pay \$1,250. of this amount, and SRC will build the road to-each Mr. Wood's property.

- 2. Classification of SRC employees in this County, and those in the Emergency Control office, as required by recent legislation, Mr. Thompson has been working on this and expects to complete same in near future.
- 3. Mr. Thompson and Jr. Paley informed the Commissioners that 9 men would start work August 16, on County roads -they had been selected earlier and had to be cleared by the SRC.
- 4. Sen. Dorsey and Henry Russell came regarding Mr. Russell's interest in being made foreman of the 4th Dist. Commissioners and Mr. Thompson informed them that SRC does not have enough laborers to create a crew in the 4th Dist. They have a crew in the 5th D and the 7th D. Sen. Dorsey read a petition with 150 names signed, requesting that Tr. Russell be made foreman of the 4th D. Commissioners further explained that all County Road employees are hired and fired by the SRC and the only way to have a crew in the 4th D. would be employ 4 to 5 additional laborers and SRC does not think this is possible at this time.
- 5. Willows Rd to be estimated by  $^J$ r. Raley in the fall. This is now a Fed. aid road and will be set up for construction in the summer of 62. Jr, will be sure the R/W of 50 ft. has been secured, which is necessary due to heavy traffic on this road.
- 6. Copy of program for \$103,000.00 to be refunded when Bond series 8 has been sold. Check in the amount of \$46,344.41 advanced to SRC program, on file for which these funds are to be used.
- 7. Commissioners signed a letter approving roads for Emergency Snow roads State Police will decide when this program goes into effect, when snow tires or chains must be used R.5 & 235, Chas. Co to ex. Pk

8. Sen. Dorsey returned and presented a letter on behalf of Deputy Ben Burroughs, regarding expenses he will incur while attending FBI Academy in Washington, DC, requesting Commissioners to pay \$750.00. No decision (Letter in file)

SRC at 1:30 Jr. Raley returned to meet with John Bean who wants County to accept road leading into his place of business, Wynne, which also serves

Bond for surface treatment to be furnished by Bean, also 4 plats of the road. Jr. Raley advised the Commissioners the road is practically up to SRC specifications .

at 3 pm the Commissioners met with the newly appointed Economic Dev. Comm. all of whose members were present. After greeting the new Commission, the Commissioners retired to other quarters while the E.D.C. held a business meeting which lasted until 3:45 when they left.

Commissioners returned to their room to complete unfinished business Letter from M.C. Thompson, Jr had advised the Commissioners of the destruction of 3 windows in a shovel belonging to the SRC, left at Jack Mattingly's gravel pit at Bay View. 3 boys, aged 8-9-12 years, sons of Jas. H. Lysle were found to have caused this damage. Mr. Lysle had informed Mr. Thompson he could not afford to pay for repairs to shovel ' Mr. Thompson asked the Commissioners what should be done.
