All officials present except atty. Sterling.

Charles Jos. Herbert came in with reference to changing his Paro. School bus route, from Clements to Morganza. Formerly went up main road from Morganza to Clements, now no children between Sunnyside to Morganza on main road, but a few from Sunnyside up to Loveville, the road he is now travelling and it is  $\frac{1}{2}$  mi further each way than the old road-only goes that way in the morning, not in the evening, adds 1 mi per day to contract- $20\phi$ , began Jan 1st

Geo. E. Lacey (paro sch bus driver for Sam Bailey) Billy Hammett and Buck Lawrence for the Holy Angels PTA reported Lacey drives bus with 75 children on it. He thinks that because there are 4 busses going to Holy Agnels School and some travel over his route, and they could relieve his bus of some of the children. It is contemplated that Frank Ellis' bus will pick up some of these children. PTA and bus drivers will work it out. Any extra mileage for this will be reported to the Commissioners..

Mr and Mrs Lloyd Johnson and Mrs. Emma Gladstone reported a bad condition in their road. Asked Commissioners to accept and maintain road and were informed that it would be necessary to have a R/W; beginning of the road in question goes thru Dr. Jacobs to Mrs. Stahl's R/W; road is .04 mile and intersects at 238. It appears that the water comes over their property from Dr. Jacob's. Mrs and Mr Johnson and Mrs Gladstone are willing to pay the cost of condemnation of the necessary land. Commissioners will look into legal aspects of condemnation proceedings and discuss this with Atty Sterling, and advise them by Jan 15th. Mr. Sterling will write Dr. Jacobs and ask price he wants for R/W.

Jr. Raley and Comms. Hodges reported on the Pearl Gregory Forest Hts matter They feel the County should build the road in to Forest Hts. If R/W can be obtained County will build the road.

Letter from Mrs. Stevens concerning Hermanville-Park Hall Road. This road was on program for building but all R/W could not be secured and this prevents the work from being done When R/W is secured where needed, road will be rebuilt. In the meantime road will be kept usable.

Mrs. Rosemary Abell was interviewed and appointed to the position of Switchboard operator for the Court House, effective Jan 15, 1962 at a salary of \$45.00 per week; hours 9 a.m. to 4:30 p.m. except on Saturdays during license time, 9 a.m. to 12 noon. Several employees in the Court House have been requested to learn to operate the switchboard in case of emergency.

Commissioners approved sirens for the Sheriff and deputies, this will be a 12V heavy duty siren \$65 each, with Fed. tax Ordered.
