School for Retarded children- and Work Shop
Dr. Chas. Greenwell, Mr. Paul Ludwig and Col. Simpson, interested in securing the old Alms House building for a school for retarded children, and a small section of land for a work shop- for retarded adults also, They presented an estimated cost of operation of such school. Col. Simpson advised that for about \$10,000.00 the standing building could be renovated into the school they desire. No decision could be made until after the Commissioners receive a report as to how much land etc is required by the State Dept. of Health for the proposed Nursing Home and whether or not the sewage system- by lagoons- is satisfactory to that Bd. After this informtion is received the Commissioners will arrange a meeting to discuss the school, with new Commissioners present.

At 10:30 Mr. Wiley Hartwell, representing the local Health Dept., with J. Louis Mattingly, Special Inspector and Killian Laschalt, real estate agent, appeared regarding Bldg Termit #2334 issued to Robt. Armstrong for a site on the Hurry Rd where no Percolation Test had been approved by the local Health Dept. Upon advice of Atty. Sterling, the Commissioners decided that Robt. Armstrong is to secure a new Bldg Termit for the above home, after he has cleared with the Health Dept for Percolation Test and any other requirements of that Dept.

Article for Publication

Atty. Sterling is to prepare an article for publication in the County newspapers regarding rew rules for any Bldg Permits and Plumbing applications issued in the future, in cooperation with the local Health Dept.

Petition- Clifford Fuller

A petition received from Cliffor Fuller, bus driver of parochial school bus for Paul Bell was reviewed by the Board. Letter to be sent Mr. Fuller advising him that the Commissioners have no control over such drivers unless they prove unsatisfactory. Also advising him that if and when any new bus routes are anticipated notice of same will be published in the County papers.

Spring Ridge Rd- 1st D.

Delegation from Spring Ridge Rd. requested the Commissioners to take over the road and improve it etc. They were advised that it would be necessary for them to secure a Petition signed by all the property owners along this road agreeing to give necessary land for a 40 ft R.W. that the road must be surveyed, staked out and built according to SRC specifications, inspected by the County Rd. Supervisor and if approved by him, the Commissioners would include it in the County Roads system for maintenance only. Above work at no cost to Commissioners, only maintenance cost after road is accepted.

Tr. Raley, County Rds. Supervisor made his regular weekly report that work is progressing satisfactorily. Check for \$2,500.00 was given to SRC for Sanitary Fills and Wharves.
