Letter to Mr. Tilp, anclosing ketter received from Commus. Hodges, requesting Mr. Tilp contact the parties named in the letter:

Col. Peake brought to the attention of the Commissioners that his wife had purchased the property of Robt. M. and Mary L. Jackson, located in the 1st Election District, at a tax sale, for non-payment of State and County taxes for the year 1958. It developed that this property was in the names of the Jacksons, but had been conveyed by the Jacksons to Henry E. Rains and wifeprior to 1958, and this property was assessed to the Rains for 1958 and the Rains paid the 1958 taxes. Col. eake demanded reimbursement, also damage for loss of profit, and inconvenience. The Commissioners advised him they would reimburse his wife only for the amount paid for the property at the tax sale, also all taxes she has paid since the tax sale, and her proportioned share of the cost of the Court proceedings to foreclose the equity of redemption, which she instituted in 77
