All members were present at today's regular meeting, as well as the Commissioners-elect- Messrs. Bowles, Burch and Ridgell. Minutes of previous meeting were approved as read. Vouchers for payroll and expenses were signed. Payroll was to Nov. 30, 1962.

Coin. Op. Machines J. Louis Mattingly, Inspector, reported that certain machines were not licensed- or carrying the required license for 1962-3 in a conspicuous place. Mr. Mattingly was instructed to make a complete check of all machines in this County on Nov. 13th. He is doing this.

Trailer Parks. Inspector Mattingly reported that he is following instructions given him on Nov. 13th, regarding Occupancy Fees and Licenses on Trailer Parks to see that they are brought up to date. Then followed a general discussion concerning accounts of Trailer Parks- no further action was necessary.

Single Trailers located in this County, and moved from place to place, was then discussed. Mr. Sterling advised that such trailers come under the jurisdiction of the office of the Assessor and Treasurer, and only indirectly under the County Commissioners.

Town Creek Streets- Pine Court. Commissioners agreed to accept Pine Court, in Town Creek subdivision, when a bond for \$500.00 for surface of this road is posted by Mr. M.M.Dean, owner of the subdivision. Plats and Deed for this road are now in the Court House. Above was complied with on Nov.20th and 21st and letter was written to Mr. Dean advising him of this.

New Roads Subdivisions

The Commissioners decided that in the future all new roads in subdivisions are to be surface treated with slag or crushed stone. This applies to Pine Court-Town Creek. Also, said work to be paid for by the owners of these subdivisions, not by the County Commissioners.

Oyster Permits. Atty. Sterling advised the County Commissioners that any female having no visible means of support, may procure a Permit to take oysters from any natural bar in St. Mary's County, during the oyster season. There is no charge for such Permits.

Sen. Elect J. Frank Raley Jr., appeared before the Board and requested that the retiring Commissioners and the Commissioners-elect meet and confer on certain legislation, which they propose to have introduced at the session of the Leglature which convenes January 1963.

Sanitary Fill 8th Elec.Dist

Mr. Raley further requested that a Sanitary Fill be located in the 8th Elec. Dist. He was requested to try and locate a suitable site.

Comm. Elect Burch requested that Mr. Sranley Donaldson prepare a statement as of Dec. 1, 1962 showing the outstanding balance of each of the several categories of the County for the 62-63 Budget, showing what portion of their allotment each of these accounts had used, under the 62-63 budget. This is to be presented to the new Commissioners when they take oath of office Dec. 11,1962.

Also the bank balances, and any other information which Mr. Donaldson can furnish that will facilitate the work of the new Commissioners.
