#### Fire Training Program

Mr. R. Moore said that Leonardtown Fire Department is requesting use of the Alms House as a training ground for their men, and also men in other companies. Mr. J. Mattingly, their chief, plans to enter into rather extensive drilling for the men, using the house, and would eventually burn it down. They have set a six month limit to accomplish this, and Mr. Burch asked if this could be shortened. Mr. Moore said if the commissioners put a time limit on the project, it will be accomplished within that time.

The commissioners will let Mr. Moore know their decision, and felt that a stipulation in the letter, if permission is granted, should state that the fire department will clean up the area after the project is completed. Mr. Pantaleo will inspect the house to see what can be salvaged for future use by the county.

#### Route 235 - Hollywood

Mr. M. Dean and Mr. W. Kirby from Hollywood area. Mr. Dean presented petition to the commissioners regarding the construction of Route 235 in Hollywood. Petition requests the SRC to widen the road, following its present location, using the existing 60' right of way, and constructed with curb and gutter from Vista Road through Hollywood. All of the people on the petition are those who would be directly involved up and down the road. The Fire Board has also signed the document as being in favor of the road alignment requested.

#### Extension Jones Wharf Road

The commissioners approved the corrected plat and deed for the additional right of way for widening the extension of the Jones Wharf Road leading into Hollywood Shores. Mr. Burch signed same. Letter will be sent to the SRC requesting that this road be placed in the County Road System.

#### Extension Thompson-Mattingly Road

The commissioners agreed to accept said road, and deed and plat were signed by Mr. Burch. Letter will be sent to SRC as required.

#### Direct Telephone Line

Mr. Bowles made motion that a direct line be installed in the commissioners conference room, seconded and passed unanimously. This will be an unlisted number, with two lines, one to the office and the other into the conference room.

#### County Water and Sewage Plan

The four firms who were interviewed will be requested to submit proposal for this project by February 15, 1967.

Route 235 Traffic Hazard

Letter will be sent to the state police and the sheriff requesting that an investigation be made of the hazard created by rocks being deliberately placed on Route 235 from Hermanville to St. James Road.

Road Signs

Letter will be sent to SRC requesting "children at play" signs on the Airdele Road, 1st District, and "not a through street" at intersection with Route 235, as requested by Mrs. A. Lewis, resident. Copy of letter will be sent to Mrs. Lewis.

Traffic Control - Nursing Home



Surveyor's Transit, etc.
