Dog Damage Claim

The commissioners reviewed claim from Mr. B. E. Tennison, Scotland, for 8 hogs killed by dogs and approved payment of \$20.00, totaling \$160.00.

Roads

Mr. Pantaleo reported that on the Strickland Road, it was his understanding that Mr. Jr. Raley was getting the right of way needed here, and is working on it now to obtain same from a Mr. Goode. Stakes on the Chancellors Run Road will be set at 40' instead of 50' as this might take too much property. About 80% of the road will accommodate 4' shoulders, with a 20' roadway. This would be with the road as it is now without realigning it. There will be 6' on each side for the ditch line, and there might be some fences, poles, etc., that will have to be moved. Mr. Burch suggested that if we have to move some pipes back, it might be best to get additional right of way and only have to move them once. Mr. Pantaleo will work up a cost estimate on this project and present same to the commissioners.

A decision will have to be made on the St. John's Road as soon as possible. Mr. Burch said that the SRC can condemn this property if necessary to get the project completed. There is one person on the road who is being difficult in this respect. Mr. Pantaleo said he and Mr. Jr. Raley showed Mr. Harris, who lives on this road, what was going to be done regarding his drainage problem, but Mr. Harris said they were not going to do this the way they had agreed. Mr. Pantaleo called Mr. Thompson and the latter stated he did not tell Mr. Harris anything of the kind. General discussion and Mr. Burch and Mr. Pantaleo will meet on the site later this week, and possibly have Mr. Thompson and Mr. Harris present.

Sanitary fills - Mr. Pantaleo will check matter of fill at Compton so far as rights of owner are concerned. Reviewed report of fencing and signs required and Mr. Pantaleo's recommendations. He and Mr. Raley will get as good a price as possible on these items and purchase same.

Tall Timbers Wharf - Mr. W. Wise has said he will remove and dispose of all the debris and trash in this area for \$100. This would be for a general cleanup of the lot. Amount of easement around the public wharf will be checked by Mr. Pantaleo. Mr. Aud also suggested having the barrels of dead fish removed from the wharf at St. George Island. Mr. Burch will inspect the Tall Timbers area before a decision is made.

Plan for Shangri Ia Drive has been drawn and Mr. Pantaleo asked about advertising this. He stated that the waterline will have to be lowered in one place, and the manholes will also have to be lowered; the sewers are all right. Mr. Pantaleo said he can furnish the company with a map of the area, and he will talk to Mr. Gabrelcik about it. He will also write specifications and this will be advertised.

Mr. Guyther came in at this point.

General discussion concerning an assistant for Mr. Pantaleo and he will write a job description for this position.

Mr. Pantaleo will get estimates from several contractors for the Wise-St. Andrews Road, and an estimate from the SRC, including all overhead expenses.

Mr. R. Moore of McCrone, was called into the meeting regarding the Copeland property. He stated that the survey on the property will be completed by the middle of June.

County Water and Sewage

Mr. Guyther informed the commissioners that the county has met the requirements of competitive bidding as set forth in the state law.

Oiling Schedule

The commissioners approved issuance of a check in the amount of \$93,120.92 to be advanced to the SRC for the oiling schedule, to be reimbursed from the 14th Series Bond Issue, said money to come in in August.

Sheriff

Mr. P. Raley and Sheriff Burroughs. The sheriff stated he would like to purchase a small tear gas pump for each of his deputies as he feels there is a definite need for them. They cost approximately \$8.00 each. The commissioners approved purchase of the pumps.

Mr. Burroughs inquired about his request for two additional cars, and the commissioners agreed that the bid advertisement would be published immediately, and Mr. Raley will take care of this. The sheriff requested that a delivery date be mentioned in the advertisement. It was agreed that 45 days would be allowed from the date of award of the bid.

The sheriff asked for a secretary to handle typing and telephone calls while Miss Wood is on leave. Mr. Raley will work something out with the people available in the court house.

Mr. Burroughs mentioned problem with the antennas at the control center. There is a dead area from the Halfway House to the county line. The fire board antenna is in the way of their getting the 360 degree range they are supposed to have. The commissioners agreed that the sheriff should coordinate this andget the corrective that is needed accomplished.

Tax Exemption.

Mr. Raley said he will publish information concerning the tax exemption applications for people over 65 years of age. He then left the meeting.

Mr. Burch and Mr. Bowles approved payment of \$10.00 for the sheriff and \$5.00 for each deputy to join the Sheriffs Association.
