7 Gables Bulkhead

Mr. Burch reported that Mr. M. C. Thompson is recommending that the SRC do the entire project. The commissioners agreed, and Mr. Thompson will be so notified.

County Auditors Fees

Reviewed statements from Mr. David Gruber, County Auditor, and these will be checked with Mr. W. King of that firm when he comes to the county this week.

Sanitary Fills

Approved payment to Mr. W. Wise for first payment for maintenance of county fills in the amount of \$1600.00, as approved by Mr. Pantaleo. This is the monthly allocation under the terms of the contract.

Parks and Recreation

The commissioners approved payment of \$439.54 for expenses from May 4, 1967, and Mr. Donaldson will check appropriation remaining in the budget.

Tire Bid Opening

Mr. Guyther and Mr. P. Raley (Mr. Donaldson absent). Tires bids opened by Mr. Raley with Southern Oil Tire Company apparent low bidder. As this company is located in Waldorf letter will be sent to them asking where tires will be delivered in St. Mary's County, and if charges for mounting and balancing are included in the price quoted, or extra. After this information is received, the contract will be awarded.

Car Bids for Sheriff

Only one bid received from the Patuxent Motor Sales, \$2,693.45 for a Mercury Monterey, 4 door sedan. If power brakes are desired, add \$32.64 to each unit. The commissioners agreed that the bid should be awarded to this firm and the cars should be equipped with power brakes. The bid is for two cars.

SRC Costs

Mr. Burch said he would like to have an accounting from the SRC of expenses up to the end of June 1967, and Mr. Donaldson will be asked to get this information.

Millstone Landing Road

The commissioners agreed that Mr. Guyther should proceed to work out the problems between the individuals concerned on this road.

Statement of Assurances from Nursing Home

The commissioners reviewed same with Mr. Guyther and Mr. Bowles took the statement and will compare it with the original one that was sent in.

County Engineer's Secretary

Mr. Donaldson present. Reviewed letter from Mr. Pantaleo answering letter from the commissioners' office relative to placement of Miss Cecelia Battenfield on permanent status, as her probationary period has ended. Mr. Pantaleo recommends reassigning her to another office or extending her probation for six months, as he does not feel she has the proper interest or initiative in his office. As the commissioners are meeting with the State Commissioner of Personnel, Mr. R. Davis, on Wednesday, this will be discussed with him.

Alms House Property

Mr. Guyther will be asked about status of rental of this property by Mr. E. Bell, as this must be terminated as soon as possible, as the ground is needed for other purposes.
