Langley Trailer Park-Powell Trailer Park

The Commissioners approved and signed the plats for Charles Langley Trailer Park in Great Mills for 30 trailers. Also, approved two trailers for the Powell Trailer Park on the Curley Road in Ridge.

State Aviation Commission

Reference was made to a letter received from Mr. David Snyder of November 6, 1968 regarding the availability of State funds for the Airport project. Letter to be sent stating the amount spent to date (\$58,638.62), also the plats sent by Rader & Asscts. for Mr. Snyder's signature.

Beavin Company

Approval was granted in the amount of \$1,800 for engineering services on the Master Water and Sewerage Plan for December 1968. Mr. Donaldson will also approve said bill before it is submitted to the Health Department for payment.

Road Request

A letter was read from Col. L. Peak regarding road on which he lives off the Seven Gables Road in the 8th District. He requested the County to condemn said road for a 30 foot right-of-way since the people would not give it.

Payment of \$30 was approved for membership fee of Judge Alice Taylor to the North American Judges' Association.

Rader & Asscts.

Mr. Burch and Mr. Aud approved bill in the amount of \$2,000 to Rader & Asscts. for the December fee on the Airport project.

Roads Program

Mr. Dennis Raley, Jr. stated that the County would need a loader and a trailer for use in the county disposal areas. He stated that he had invited Mr. Chuck Claypool to draw the specifications for a 1 3/4 yd. bucket and also 1 1/2 yd. bucket. Mr. Claypool will meet with the Commissioners next week.


