#### Tuesday, April 17, 1973

#### READING OF MINUTES

## VOUCHERS APPROVED

Vouchers Nos.4481 through 4659, dated March 12, 1973 through April 12, 1973, were unanimously approved.

## COOLING TOWER CONTRACT - CONTROL CENTER

Present: Otis Wood, Acting Director, Civil Defense

Mr. Wood stated J. Carroll Morgan would not accept the cooling tower contract with the penalty clause.

Commissioner Aud made a motion that the Commissioners sign the contract, between the County Commissioners, Civil Defense, and J. Carroll Morgan & Son, without the penalty clause, to install the 20-ton cooling tower and such other equipment as the contract may call for. Commissioner Guy seconded the motion and Commissioner Bowles made it unanimous.

### CENTRAL COMMUNICATION SYSTEM

Present: Otis Wood

Mr. Wood presented a letter to the Commissioners in which he requested they not approve funds requested by the Sheriff that would lead to the decentralization of the dispatching facilities for the emergency and law enforcement agencies for St. Mary's County. The present system is economical and more efficient when more than one system is involved.

#### TRI-COUNTY GROUP HOME

Commissioner Aud stated Tri-County Group Home wrote a letter to the Governor's Commission on Law Enforcement requesting an extension of time until September. The deadline is presently June 1. The proposed location of the Home has been dropped and, therefore, an extension is needed to look for another location.

A letter is to be sent to LEAJ Planning Board, Attention Clark Gravelle, requesting an extension of time.

#### ORDINANCE NO. 73-8

Commissioner Aud made a motion that the Commissioners sign Ordinance No. 73-8, concerning State Code for industrialized buildings and mobile homes, effective this date. Commissioner Guy seconded the motion and Commissioner Bowles made it unanimous.

## AMENDED ZONING APPLICATION - WILLARD B. LONG

A letter was received from Willard B. Long requesting his application and plat for zoning be amended. Commissioner Aud made a motion to zone the unzoned property of Willard B. Long to "Commercial", as shown on the amended plat, as outlined in red, attached to the letter. Said zoning No. 0002 is prepared by Lorenzi, Dodds and Gunnill Contract No. 72742; said commercial zoning is a depth of 600 feet on the southwesterly side of the railroad right of way, having a frontage of 1245 feet paralleling the southwesterly side of the railroad right of way.

#### RESOLUTION - OLD ROUTE 5 (OAKS ROAD)

Commissioner Aud made a motion that the Resolution for a 30-mile per hour and Children at Play sign for Oaks Road be signed. Commissioner Guy seconded the motion and Commissioner Bowles made it unanimous and signed same.
