#### READING OF MINUTES

The minutes of June 25, 1974 were read and corrected.

## APPROVAL OF MINUTES

Commissioner Aud made a motion to approve the minutes of June 18, 1974, seconded by Commissioner Bowles, who signed same.

#### APPROVAL OF BILLS

The following bills were approved by the Commissioners:

# FEDERAL REVENUE SHARING PROPOSED EXPENDITURE

Mr. McGlade presented the Federal Revenue Sharing proposed expenditure for fiscal year 1975 funds in the amount of \$993,093.00. Commissioner Aud made a motion authorizing Commissioner Bowles to sign same, seconded by Commissioner Bowles.

## SIDEWALK IN FRONT OF BAY DISTRICT FIRE DEPARTMENT

Commissioner Aud made a motion to approve the replacement of the sidewalk in front of the Bay District Fire Department at Rte 246 and fronting on Coral Drive in an amount not to exceed \$300. Mr. Aubrey Gatton is the contractor. Commissioner Bowles seconded the motion.

#### RESOLUTION NO. 74-27 ECONOMIC IMPACT FEE

Commissioner Aud made a motion to approve and sign Resolution No. 74-27 - Economic Impact Fee regarding the passage of House Bill 1497, seconded by Commissioner Bowles.

## MARYLAND ENVIRONMENTAL SERVICE - LOWER POTOMAC BASIN

A letter dated June 3, 1974 was received from Maryland Environmental Service stating they are establishing two advisory groups in the Lower Potomac Basin, and requesting names for the Public Advisory Council and Government Policy Group. Commissioner Aud made a motion to recommend Joseph E. Bean, Great Mills; James T. Tennyson, Mechanicsville; Kenneth Dement, Calloway; and MacGuire Mattingly, Jr., Leonardtown, for the Government Policy Group and James Beavan, Chaptico (Soil Conservation District Supervisor) and Nick Smith, St. Mary's County Chamber of Commerce, Leonardtown, for the Public Advisory Council. Commissioner Bowles seconded the motion.

# RECLASSIFICATION - LINDA DELOZIER (RECREATION AND PARKS)

A letter was received from Commission of Personnel recommending approval of the reclassification for Linda DeLozier, from Secretary A to Secretary B, in the Recreation and Parks Office. Commissioner Aud made a motion to accept this recommendation, seconded by Commissioner Bowles.

# REQUEST FOR PERMIT TO CROSS RAILROAD RIGHT-OF-WAY - TELEPHONE CO.

Ed Cox stated that John Norris, County Engineer, received a request from the C & P Telephone Company for a permit to cross the railroad right-of-way at Charlotte Hall and Hughesville to place ducts under the railroad right-of-way near the intersection of Route 5 and Route 6 and near the intersection of Route 5 and Route 231. The Commissioners instructed Ed Cox to request the telephone company to submit plans showing location and depth and material to be installed to the County Engineer's Office.

# GRANT REQUEST - INVESTIGATOR COORDINATOR

Ed Cox stated that a Grant Request for Investigator Coordinator and Statement of Grant Award and Conditions was received from the State's Attorney's Office, requesting the Commissioners' approval for submission to Governor's Commission on Law Enforcement. Commissioner Aud made a motion approving the Grant Request and authorizing Commissioner Bowles to sign same, seconded by Commissioner Bowles.

## SEDIMENT CONTROL PROGRAM

A letter dated June 24, 1974 was received from Water Resources Administration stating a meeting has been scheduled for August 1 at 10:00 a.m. of the Sediment Control Task Force. Ed Cox was instructed to request John Norris, County Engineer, to coordinate this with the St. Mary's County Task Force members.

#### PERSONNEL RECLASSIFICATION STUDY

Ed Cox requested permission from the Commissioners to go to Philadelphia to work on the final auditing of the positions in the Personnel Classification Study conducted by U. S. Civil Service Commission, July 18 and 19. The Commissioners gave their approval.

## MOSQUITO CONTROL PROGRAM

(See minutes of June 25, 1974) Mr. McGlade presented a letter to be forwarded to David Gruber & Company requesting them to check the validity of the budget amounts in question and to make a determination of the County's authority to pay the deficiencies.

Commissioner Bowles announced to the Press that Joseph Ernest Bell, Planning Commission Attorney and Joseph D. Weiner, County Attorney, have submitted letters withdrawing their resignations to their respective Commissions and will remain with the County through the calendar year 1974.

## LIGHTS FOR LEONARDTOWN TENNIS COURTS

Mr. Baggett came before the Commissioners to advise them that the Town of Leonardtown will pay up to \$2,000 for the lights at the Leonardtown tennis courts and he requested permission from the Commissioners to apply for a three-quarter grant to Program Open Space for the lights and to request the Commissioners to endorse the installation of the lights. They will be taken into the Recreation and Parks System and maintained by the County. Lighting will be on a metered system and meters emptied by the Town Policeman.

The Commissioners gave their approval to Mr. Baggett's requests.

In the suit against the Sheriff, in which the County Commissioners have been made a party to, Mr. Weiner advised the Commissioners that the Commissioners are covered under their liability insurance policy. Frank A. Combs, Agent for the insurance company, had advised Mr. Weiner that the insurance company will represent and defent the County Commissioners in Baltimore.

## ECONOMIC AND COMMUNITY DEVELOPMENT (PLANNING)

Present: Leon Pederson, State Economic and Community Dev.

Mr. Pederson came before the Commissioners to explain a new program being developed with the State EDC involving planning. Mr. Pederson will be the liaison with Southern Maryland and will be located at the Tri-County Council Office. He stated that he is interested in what planning has taken place in Southern Maryland and would be able to provide information and data to our County. Ed Cox inquired if he would be involved in tourism grants to which Mr. Pederson replied he would. The program will take 18 months to get underway. Commissioner Bowles suggested that he meet with our County EDC, Planning Commission and Zoning Administrator.

#### AMENDMENTS TO ZONING ORDINANCE

At this time the Commissioners read and reviewed the draft Resolution - Amendment No. 1 to the St. Mary's County Zoning Ordinance.

#### AGREEMENT - ST. MARY'S COUNTY ZONING ORDINANCE

The Commissioners reviewed the Agreement between Barton-Aschman and the County Commissioners for the amendments and printing of the final Zoning Ordinance.

Commissioner Aud made a motion that the Commissioners approve this Agreement subject to clarification of Item No. 6, Page 3 of the Agreement as to the number of manuals for the amount of money stated therein and also subject to review of the original contract to ascertain any duplication of work, seconded by Commissioner Bowles.

# METROPOLITAN COMMISSION RESOLUTION AND NOTICE OF INTENT TO APPLY FOR FEDERAL AID

Commissioner Aud made a motion to approve the Notice of Intent to Apply for Federal Aid by the Metropolitan Commission for Contract 8B-S, Bay Interceptor Extension; 14-S, Parallel Force Main; and 15-S, Fisherman's Creek Waste Water Pumping Station and related lines and to approve the Resolution of the St. Mary's County Metropolitan Commission "providing for the expenditure of not exceeding \$100,000 from the St. Mary's Metropolitan Commission District Fund to provide funds for the design, construction, establishment, purchase or condemnation of the water supply system in the Pine Hill Run Sanitary District in order to meet an emergency water supply situation existing in the water system supplying the Pine Hill Run Sanitary District; providing that the said amount shall be used only to provide funds for capital expenditures for which bonds of the St. Mary's County Metropolitan Commission may be issued; and generally relating to the transfer of such funds and related procedures." Commissioner Bowles seconded the motion.
